"You have to wait till Christmas." "Its as slow as Christmas." We have heard these lines many times in our lives,

either as children waiting to open Christmas presents or in later years waiting on something or someone.

When we think of December, many times we think of Christmas and all that it brings. But the Christmas season is only a short time of December (12 days) and half of that is in January. It is the highlight of this time of year, but never the less, the time of December is filled with another season -- Advent (November 30 - December 24).

"Advent means "coming" and thus "coming" is the emphasis. We remember the faith of the Old Testament believers who looked in hope to Christ's first coming. As Christians, we look in anticipation to the second coming. We prepare for the coming celebration called Christmas on December 25. We recognize that Christ continues to come to us in the present through Word and Sacrament.

Thus in our worship service, in our hymns, Scriptures and prayers we emphasize "coming" and preparation and then celebrate Christmas when Christmas comes. This is different from the secular world which tries to push Christmas on us for more than a month

before Christmas Day. Because of this, we may lose the importance of waiting and anticipating, and then trivialize Christmas when it does come. The emphasis of the church is that these weeks before Christmas are a time of reflection and anticipation preparation, so that when Christmas comes, we can truly praise God for His wonderful gift of a It may seem as "slow as Savior. - 1. Let us know if your youth is registered as you do this online so we will not know you have done it.
- 2. A \$175.00 deposit sent to the office for your youth (note: this is refundable upon the attendance of your youth at the camp)

Please don't let money be a problem for the youth attending camp. This is such a marvelous experience and faith building week we don't want anything to get in the way of them attending. Just let Terry or the church office know.

We know summer schedules can get tough to work everything in. It is much easier to subtract a registration than to add one and sometimes that week may be full already. So, if there is any doubt please go ahead and register.

CHURCH COUNCIL MEETING ST. PAUL LUTHERAN CHURCH November 11, 2025 @ 6 PM

Empowered by the holy spirit to make Christ known; as we love one another, serve our neighbor, and grow in our faith through studying God's word and worshipping God.

- 1. CALL TO ORDER- The meeting of the Church Council of St. Paul Lutheran Church was called to order by Boyd Weise, President. Council members present for the meeting were Boyd Weise, Wade Bolting, Calvin Bruns, Jill Turner, Laurey Garcia, Larry Gohmert, Jay Heil, Pam Hoefling, Ashleigh Peyton, Susan Franke, and Pastor Tim Muehlbrad. Terry Carmichael, Chad Hahn, and Chris Gohmert were also in attendance.
- 2. **DEVOTION-** Jill Turner opened the meeting with prayer.
- 3. MINUTES- Pam Hoefling made a motion and was seconded by Ashleigh Peyton to amend the minutes from October on Social Concerns to change August 2025 to September 2025. Pam Hoefling made a motion to approve October 14, 2025, with the amendment. Ashleigh Peyton seconded. The motion carried.

4. REPORTS-

- a. **Treasurer/Stewardship-** Calvin Bruns provided a written report.
- b. Parish Education- Jill Turner Reported:
 - 1. Bibles were presented to the 2nd-grade Sunday School class on October 26th.
 - 2. Erin Koopmann will be the Christmas Program director. Play practice will be during the Sunday School hour on November 30th and December 7th.

Dress rehearsal will be on Saturday, December 13th at 2:30 PM. The Christmas play will be performed during the church service on December 14th.

c. Youth Committee Report- Laurey Garcia reported:

- 1. Ten youth (Hanna Kneese, Gwen Kneese, Molly Gause, Abigail Gaus, Bailey Gaus, Kellan Diehl, Kylie Diehl, Aydn Garcia, Paige Rippamonti, and Ellen Warwas) came to assist on our workday. We cleaned and polished all of the pews in the sanctuary and made \$2,000 to use towards the Sports Court Fund.
- 2. The J. Welsh Farm outing was cancelled due to a lack of interest.
- 3. On November 15th, the youth is scheduled to play Bingo with the Yorktown Manor residents at 9:45 am.
- 4. Our next meeting is scheduled for November 18th at 6 PM.

d. DCE- Terry Carmichael reported:

- 1. Besides the normal duties (Childcare Chapels, Sunday School, and other duties), the following were accomplished:
 - a. Have been providing elementary Sunday School teachers with downloading and then copying their new curriculum materials for the month and placing them in their binders in their classrooms.
 - b. Have been looking through the NALC National Youth Gathering registration materials.
 - c. Have been looking through the Camp Lone Star Group Registration materials.
 - d. Met with Pastor and Laurey Garcia on those registrations and what they offer to the Confirmation and Youth Programs.
 - e. Met with parents and youth about the two events and their costs, requirements, and expectations (NOTE: the results of the meeting were that we would pursue the summer camp option over the

- youth gathering due to the time and costs of the event).
- f. Assisted Pastor with teaching the Confirmation classes.
- g. Led the worship services on 10/26 with assistance from Jay Heil and gave the sermon to allow Pastor to attend the NALC Pastor Retreat.
- h. Will be assisting with the Sat Nov. 8th Sunday worship with help from Jay Heil and then giving the message at the women's Thank Offering Worship on Sunday, Nov. 9th.
- i. Attended the volleyball playoff game in Seguin.
- Have been working with the Christmas Program for Dec. 14th by asking about a director and providing resources.
- k. Attended the city-wide "Trunk or Treat" event and assisted with popcorn.
- 1. Will be assisting Pastor with the guide classes on Wednesday evenings.
- m. Attended several volleyball games, football games, in-town and out-of-town.
- n. Assisted with the Bible Presentation to the 2nd graders on 10/26.

e. Worship- Jay Heil reported:

- 1. Poinsettias are lined up. Mary has kept the price at \$19.50. Amanda has printed out order forms to set out in church and at the church office so that people can start ordering.
- 2. Christmas trees will go up the week before the Christmas Program.

f. Evangelism/Outreach- Wade Bolting reported:

- 2. 5 St. Paul cards were picked up by parade participants who used our facilities during Western Days.
- g. Social Concerns- Susan Franke reported:

- 1. Assistance was provided to 1 individual in October 2025.
 - a. Provided help for one individual with rent (\$100.00)
- h. Christian Life- Pam Hoefling reported:
 - 1. Christian Life had a potluck on October 26th with approximately 40 people in attendance.
- i. Property- Larry Gohmert Reported:
 - 1. M.E. Plumbing has completed their replacement of the Educational Building plumbing, for an invoice amount of \$38,809.44, which is the exact amount of their quote.
 - 2. Schroeder Air Conditioning, as of this writing, is nearing the end of the air conditioning replacement project in the church.
 - 3. Reza Roofing is working on stopping the leaks in the roof of the extension in front of the Educational Building.
- j. Cemetery- No report provided.
- k. C.E.M. Tracie Fielding provided a written report.
- 1. Pastor-
 - 1. Professional activities during October 2025:
 - a. 7 Worship Services

5. OLD BUSINESS

a. Plumbing is completed and paid for at the quoted price. Air Conditioning looks complete, but Larry will follow up to make sure. Following up on floor details. We are about \$16,700 short for all three projects.

6. **NEW BUSINESS**

- a. Endowment Committee discussed Bi-law changes to the Constitution. Changes must be presented 60 days before the meeting and the congregation 30 days before the annual meeting. Pam Hoefling made a motion to present the revised Bylaws from the Endowment Fund Committee to the congregation for approval at the congregational annual meeting set for January 25, 2026. Wade Bolting seconded. The motion carried.
- b. Yearly committee reports need to be submitted to Amanda on or before January 5th.
- c. Friday, November 21st, 9 AM, the Budget Committee will meet to set the 2026 budget to go on the December council meeting agenda.
- d. A motion was made by Pam Hoefling and seconded by Wade Bolting to amend the Church Constitution for the term of our youth council member to a 1-year term with no more than 2 consecutive terms. The motion carried.
- 7. **CLOSING-** Jay Heil made a motion to adjourn the meeting. Pam Hoefling seconded the motion. The motion carried, and the meeting closed with the Lord's Prayer.

New Business at the Annual Meeting

At our Annual Meeting on January 25, 2026, we will be voting on some changes to the Church Constitution and Bylaws

Amendment to St. Paul Lutheran Church Constitution

Constitutional amendments may be approved at a Congregational Meeting with a majority vote and need to be ratified at the next Annual Congregational Meeting without changes by a two-thirds majority vote.

The amendment is in *italics*.

12.02. The members of the Church Council except the pastor(s) shall be elected by majority vote at the annual meeting of the congregation. They shall serve terms of two years. Their terms shall begin at the close of the meeting at which they are elected. Members shall be eligible to serve no more than two full terms consecutively. *The Church Council Youth Representative member term shall be one year and shall be eligible to serve no more than two full terms consecutively.*

(The effective date of this amendment will be when the ratification vote is taken in January 2027.)

Amendment to the Bylaws

Bylaw amendments may be approved at Congregational Meeting with a majority vote.

The Endowment Committee has rewritten the Bylaws of the Endowment Fund to make the wording more concise and consistent. No substantive changes were made for the terms of the Endowment Fund. The revised version is as follows.

The Bylaws of The Endowment Fund of St. Paul Lutheran Church

Yorktown, Texas

1/25/2026

C14.01.01 Mission Statement

The St. Paul Lutheran Church Endowment Fund shall be established for the purpose of receiving gifts and bequests for the mission and

ministry of St. Paul Lutheran Church, Yorktown, TX. Income from this fund will be used for special projects including capital improvements, program expansion and the broader mission and ministry of St. Paul Lutheran. Gifts may be made at any time to this fund, including gifts in memory or honor of individuals. Also, bequesting estates or portions of estates is a vital aspect of this fund.

C14.01.02 The principal of the Endowment Fund shall remain intact so long as St. Paul Lutheran Church continues to function as a congregation. Should the congregation be dissolved or cease to exist, the accumulated assets of the Endowment Fund shall be disposed of in accordance with the provisions of the then current Constitution, Bylaws and Continuing Resolutions of St. Paul Lutheran Church.

C14.01.03 The Endowment Fund of St. Paul Lutheran Church shall be governed by an Endowment Fund Committee elected by the congregation and shall consist of five (5) members of the congregation-at-large. Endowment Fund Committee members will serve three (3) year terms and no more than two (2) consecutive terms.

- a. Endowment Fund Committee members shall be elected by majority vote at a congregational meeting.
- b. No members of the Endowment Fund Committee shall serve more than two consecutive terms after which there shall be at least a three-year interval before a person may again be elected.
- c. Elections to the Endowment Fund Committee shall be made within thirty-one (31) days after the beginning of the congregation's fiscal year.
- d. In the event of a vacancy on the Endowment Fund committee, the Church Council shall make an appointment to fill the unexpired term.

C14.01.04 The Endowment Fund shall be established and increased through gifts and bequests naming the Endowment Fund of St. Paul Lutheran Church as beneficiary. The Endowment Fund Committee may choose not to accept any potential gift or bequest. Gifts may be in the form of:

a. Cash, bequests, memorials, deferred gifts

- b. Stocks, bonds, life insurance contracts, certificates of deposit or other negotiable instruments.
- c. Real and/or personal property which can be sold for cash.

C14.01.05 Funds to increase the principal of the Endowment Fund shall be sought and accepted at any time. Donors and memorials shall be given proper recognition unless requested otherwise.

C.14.01.06 The assets of the Endowment Fund shall be invested by the Endowment Fund Committee in consultation with a Financial Advisor for investment with the long term goal of growing principal and realizing a reasonable average return on the investments.

C14.01.07 Definition of Principal

a. Principal is defined as all gifts and bequests received, plus all investment income not expended preceding the prior fiscal year.

C14.01.08 Each fiscal year, the Endowment Fund committee shall expend the lesser of:

- a. The Endowment Fund net income from the prior fiscal year or b. Seven (7) percent of the Endowment Fund principal balance at the beginning of the prior fiscal year.
- C14.01.09 Funds shall be expended as determined proper by the Endowment Fund Committee.

C14.01.10 Specific expenditures shall be made as follows:

- a. Expenditure requests for specific programs may be made by the congregational committees or organizations within the congregation. Such requests shall be made in writing to the Endowment Fund Committee by December 1st of the year.
- b. Upon approval of the request, the Endowment Fund Committee shall direct the congregational Treasurer to disburse the funds.
- C14.01.11 The Endowment Fund records shall be subject to an annual audit, and the Endowment Fund Committee shall file an

annual report for inclusion with the Annual Report of the congregation.

C14.10.12 The Endowment Fund Committee may seek legal and other professional counsel as necessary upon approval by the Church Council. Legal fees may be charged administrative expenditures and paid from available income of the Endowment Fund

C14.01.13 The Endowment Fund committee shall meet as necessary. All such meetings shall be governed by the Constitution, Bylaws and Continuing Resolutions of the congregation. Written minutes of all meetings shall be provided to the Church Council.

C14.01.14 Amendments to these Bylaws can be enacted or amended by members of the congregation at the annual Congregational Meeting or a called meeting.


